The fee is \$150.00 plus a deposit into the escrow account of \$250.00 for private streets serving two lots and the fee is \$300.00 plus a deposit into the escrow account of \$500.00 for private streets serving three or more lots (unused escrow money is returned to the applicant). Private streets serving two lots are not named. Please refer to the private street ordinance for more details. A site condominium or PUD application is \$500.00 with an escrow deposit of \$1000.00.
